A brief review of progress to date

We need to remind ourselves of what we've already achieved and identify key issues for further progress.

We have:

- a team
- a brand/logo
- a website
- a forum
- a grant
- 67 subscribers to our newsletters
- issued an-line survey on the scope of the main questionnaire
- met the public at one event since the initial public meeting
- had a brief item in local parish magazines
- had feedback on the scope of the main survey

We haven't:

- made ourselves known to statutory consultees
- made a start on the evidence base
- reviewed all the feedback we've had
- begun to design the main questionnaire

Evidence base

As we know, MACKPlan cannot simply be a collection of policies plus ideas for implementing them, no matter how sensible, practical and relevant they may be. Every element of MACKPlan, whether a review of the current position or proposals for future action, has to be linked to evidence that supports any statements made.

Stuart is engaged in supporting a number of neighbourhood planning teams on this issue. Rebecca is able to bring her awareness of how other local teams are currently dealing with this, as well as her experience of accessing and using data specific to West Devon, when drafting plans and policies for the Borough Council.

With their help, we should make real progress on this issue.

The Neighbourhood **Statistics** current website is to easy use (http://www.neighbourhood.statistics.gov.uk/dissemination/LeadHome.do?m=0&s=1440420689897&enc=1 &nsjs=true&nsck=false&nssvg=false&nswid=1366). Expand section 2 under 'more areas' to search by parish. On the Evidence base page there is a document called Neighbourhood Statistics that pulls together some of the key data sets from the census.

However, using the links in the above paragraph reveals a basic problem for us. All the information is at parish level and, as far as housing and probably some other issues are concerned, we are likely to need to look at data on a village basis.

A good guide to gathering data has been produced by Locality and is sent with this agenda.
